The adult lifejacket is approved for persons with a weight of 43 kg or more and for a height of 155 cm or more.

Retro-reflective materials and position indicating light shall be approved in accordance with the Marine Equipment Directive and bear the MED Mark of Conformity (wheelmark).

The design assessment is based on IMO Res. MSC.48(66) (LSA Code) as amended by IMO Res. MSC.207(81), IMO Res. MSC.218(82), IMO Res. MSC.368(93) and Res. MSC.481(102).
